## 1. Purpose

C&K components, as design and manufacturing company for micro-miniature tact switches, set up continuous product improvement.

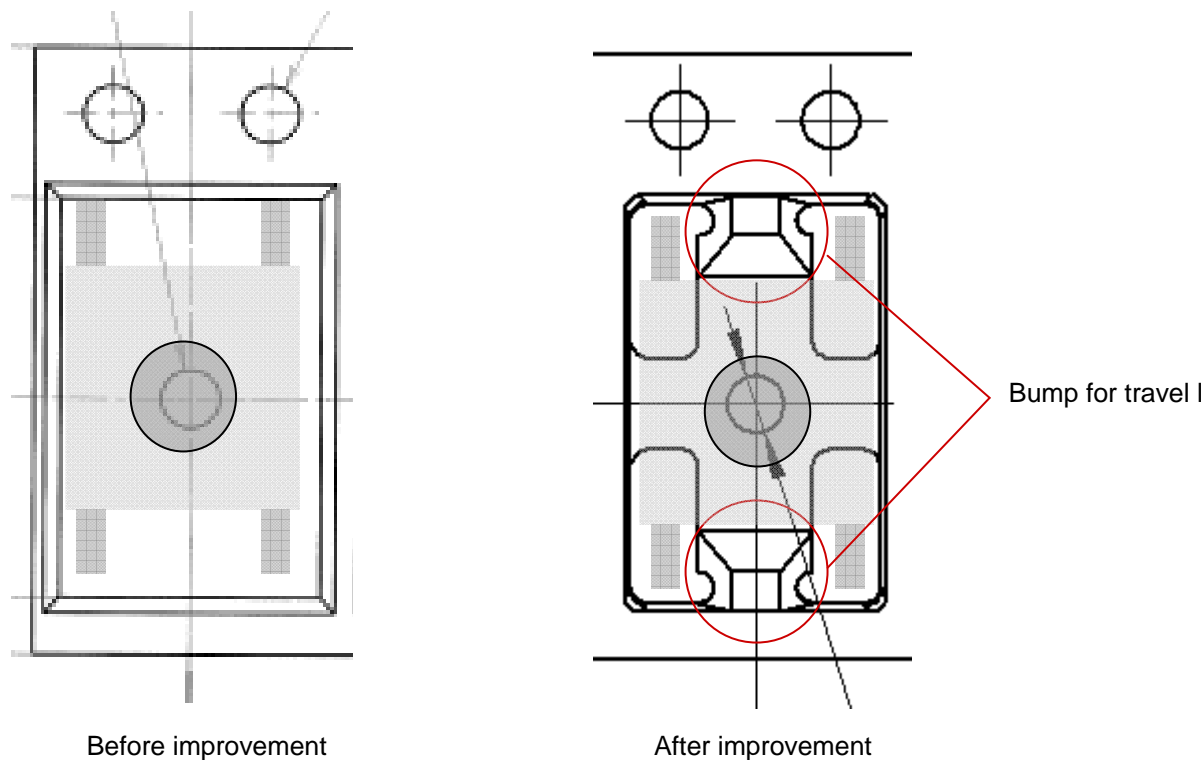
This information notice inform you about improvement performed on the tape packaging.

## 2. Update / improvement definition

The current tape for series KSC2 and KSC3 tape, for gull wing terminals (G) has been improved in order to avoid perforation of the tape by terminal during violent shocks on the reel.

The improved tape cavity design allow a guidance on the switches sides, made by bumps, and avoid contact of terminals on the cavity walls by the limitation of the possible translation of the switch during shocks. Drawing below describes the improvement.

Overall dimensions of the tape such as hole diameter, pitch, width remain unchanged.
